

#### Independent Auditor's Report

To the Board of Directors of Operational Energy Group India Limited

#### Report on the audit of the Standalone Annual Financial Results

#### Opinion

- 1. We have audited the accompanying standalone financial statements of Operational Energy Group India Limited ("the Company") for the quarter and year ended 31<sup>st</sup> March 2025, being submitted by the company pursuant to Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended) ('Listing Regulations'), including relevant circulars issued by the Securities and Exchange Board of India ('SEBI') from time to time.
- 2. In our opinion and to the best of our information and according to the explanations given to us, the aforesaid standalone annual financial results:
- a. are presented in accordance with the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations in this regard; and
- b. give a true and fair view in conformity with the recognition and measurement principles laid down in the applicable accounting standards and other accounting principles generally accepted in India of the net profit/loss and other comprehensive income and other financial information for the quarter ended 31st March 2025 as well as the year-to-date results for the period from 01st April 2024 to 31st March 2025

#### Basis for opinion

3. We conducted our audit in accordance with the Standards on Auditing ("SAs") specified under Section 143 (10) of the Companies Act, 2013 ("the Act"). Our responsibilities under those Standards are further described in the Auditor's Responsibilities for the Audit of the Standalone Annual Financial Results section of our report.     internal control.

Our conclusions are based on the audit evidences obtained up to the date of our auditor's report.

We remain solely responsible for our audit opinion. Our responsibilities in this regard are further described in para 12 of the section titled "Other Matters" in this audit report.
- 9. We communicated with those charged with the governance of the Holding Company and such other entities included in the consolidated annual financial results of which we are the independent auditors regarding among matter, the planned scope and timing of the audit and significant findings, including any significant deficiencies in internal control that we identify during our audit.
- 10. We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence and where applicable, related safeguards.
- 11. We performed procedures in accordance with Circular No. CIR/CFD/CMDI/44/2019 issued by the SEBI under Regulation 33 (8) of the Listing Regulations, as amended, to the extent applicable.

#### Other Matters

12. We did not review the annual financial statements of the two Subsidiaries located outside India. With respect to one subsidiary included in the consolidated financial results whose financial information reflects total assets of Rs.748.59 Lakhs as at 31 March 2025, total revenues of Rs.1177.32 Lakhs, total net profit after tax of Rs.21.77 Lakhs, total comprehensive income of Rs.21.77 Lakhs and cash inflows (net) of Rs.329.81 Lakhs as of 31 March 2025, as considered in the Statement have been audited by other auditors whose audit report has been furnished to us by the Management and our opinion in so far as it related to the amounts and disclosures included in respect of the subsidiary is based solely on the audit report of such other auditors, and the procedures performed by us as stated in the paragraph above. With respect to another subsidiary the consolidated financial results include unaudited financial statement whose financial information reflects total assets of Rs.8702.19 Lakhs as at 31st March, 2025, total revenues of Rs.10346.92 Lakhs, total net profit after tax of Rs.1272.40 Lakhs, total comprehensive income of Rs.1294.18 Lakhs and net cash Inflows amounting to Rs.618.22 Lakhs as of 31st March 2025.

The consolidated annual financial results include unaudited financial statement / financial information of the two subsidiaries located in India which are incorporated during February and March 2025. These subsidiaries have not prepared financial statements, since their first financial year will end on 31st March 2026, whose financial statements / financial information reflect total assets of Rs.600.33 Lakhs as at 31st March, 2025, total revenues of Rs. Nil, total net loss of Rs. 5.34 Lakhs, total comprehensive income of (-) Rs. 5.34 Lakhs and net cash Inflows amounting to Rs.25.10 Lakhs for the period from incorporation to 31st March 2025 as furnished by the management.

Two of the Nine subsidiaries are located outside India whose financial information have been prepared in accordance with the accounting principles generally accepted in its respective country. The Parent Company's Management has converted this financial information from accounting principles generally accepted in its respective country to Indian Accounting Standards (Ind AS) prescribed under Section 133 of the Act and other accounting principles generally accepted in India. We have reviewed these adjustments made by the Parent Company's Management. Our conclusions in so far as it related to such subsidiaries located outside India is based on the aforesaid conversion adjustments prepared by the Parent Company's Management and reviewed by us.

Our conclusion on the statement is not modified in respect of the above matter.

13. The consolidated annual financial results include the results for the quarter ended 31 March 2025 being the balancing figure between the audited figures in respect of the full financial year and the published unaudited year to date figures up to the third quarter of the current financial year which were subject to limited review by us.
