Tourism

The beautiful Swedish capital prides itself on being open to anyone and everyone. A curious city, eager to try anything that is new, anything that's different. Stockholm is also widely regarded as one of the world's most beautiful cities, built where the lake meets the sea, on fourteen islands, with eight centuries of history and culture to choose from.

The Royal Palace

Vasa Museum

The incredible Vasa battleship was intended to be the pride of the Swedish Imperial fleet, yet in a forerunner of the Titanic disaster centuries later, sank on its maiden voyage in 1628. The three masts on the roof of the museum are not just a tourist draw; they were reconstructed to the exact height and specifications of the original masts. This is the most visited museum in Sweden, and rightfully so. More than one million people a year come here to enjoy the different exhibitions and watch the movie on the ship's history.

Djurgården

Stockholmers are obsessed with nature, and with Djurgården's calm waterside and woodland trails. If you're into museums, the island also boasts several of the capital's most popular attractions. At the open-air Skansen, visitors can stroll through five centuries of Swedish houses and farmsteads and observe wild Nordic animals. The Vasa Museum is home to a giant seventeenth century salvaged ship, while Abba The Museum combines nostalgic memorabilia with quirky interactive exhibits.

Ladakh turns budget-friendly paradise

Ladakh, Nov 13: As winter sets in, Ladakh transforms into a serene and quiet destination, attracting fewer crowds compared to the peak months of summer. Affordable food and drinks at airports soon

New Delhi, Nov 13: In the coming days, airports will have economy zones where tea, food, water, snacks, and more will be available at affordable prices.

However, these zones will not have seating arrangements like restaurants for comfortable dining. Passengers can buy food or beverages from the counter. The economy zones at the airports are expected to open shortly. Preparations are also underway to provide an "on the go facility" for people to pack their food and take it with them.

Expensive food and drinks at airports put an extra burden on passenger's pockets. This is why many travellers have raised complaints about it. After several rounds of meetings, the Minister of Civil Aviation has reached a consensus to begin working on this issue.

The process of creating and operating such zones will begin shortly after discussions with AAI (Airports Authority of India) and other food outlets serving at the airport as well as new agencies.

Initially, such zones will be designed at newly constructed airports. In the future, there are plans to develop such eco zones at other airports by categorising and clearing space for the same.

Chennai, Nov 13: Director Siva's Suriya, Bobby Deol, and Disha Patani-starrer Kanguva will be released in theatres on November 14. On Sunday, the film's team released the trailer, which gave a glimpse into the film's story. Most of the promotional material released so far, including the trailer, hints at the film taking place in two timelines.

The Kanguva trailer was initially supposed to be released earlier on Sunday evening. After multiple postponements, it was finally released at 9 pm. The 1-minute-



30-second trailer keeps things close to the chest and doesn't reveal much. However, it does draw parallels between Suriya's timeline as a warrior and the other in present.
