Since the launch of its CSR activities, the Company has consistently supported the Yashas English School Foundation. What began as a modest contribution has steadily expanded in scope and scale, keeping pace with the institution's growth and the rising educational needs of the community. The Company has often gone beyond its statutory obligations, ensuring uninterrupted funding even during challenging times such as the pandemic. In recent years, allocations have further increased, reflecting the maturity of the Foundation's programmes and the Company's enduring belief that education is the most powerful tool for community transformation.
